Absent (A): The senator was present for session but chose not to vote or was not in the Senate Chamber when the vote took place.

Granted Leave (GL): The senator was not present for session and reported his/her need to be away from the Capitol at that time.

Order to Relieve: A bill may be pulled from a conference committee with the signatures of 12 senators. On May 12th, 2022, HB2909 was awaiting the conference committee meeting when these 12 senators pulled the bill from the committee and forced a senate floor vote. Knowing they had enough votes to PQ a conservative caucus filibuster, they intentionally waited until the end of session which robbed Missouri citizens of their opportunity to let their voices be heard on this matter.

As soon as the vote was taken, senate leadership adjourned the entire session a day early. Had it not been for these 12 senators, we might have had a very different outcome in regard to our Congressional map. They went above and beyond to ensure we did not gain a Republican seat in Congress and to silence the voices of the people.
